

Privacy Policy for SnapDay

Mobilove sp. z o.o. (referred to as "we," "our," or "us") is committed to protecting your privacy. This Privacy Policy describes how SnapDay ("the App") collects, uses, and shares your personal information. By using SnapDay, you agree to this Privacy Policy.

1. Data Controller

2. Information We Collect

a. Information You Provide to Us:

- **Account Information:** When you register, we may collect your name, email address, and password.
- **Activity Data:** Information you provide related to your activities, goals, reminders, and progress.

b. Information Collected Automatically:

- **Device Information:** Information about your device, such as operating system, device type, and unique device identifiers.
- **Usage Data:** Information about your interactions with the App, such as features you use and time spent within the App.
- **Location Data:** With your permission, we may collect location data to provide location-based reminders.

c. Information from Third Parties:

If you connect SnapDay to third-party services (e.g., Apple Health), we may collect data shared by those services with your consent.

3. How We Use Your Information

We use your information to:

- Provide and improve SnapDay's features and services.
- Allow you to set and manage goals, reminders, and track your progress.

- Communicate with you regarding updates, support, or promotional offers (if you opt-in).
- Ensure the security of the App and detect fraud or misuse.
- Comply with legal obligations.

4. Data Storage

SnapDay uses **Core Data** and **iCloud** to store user information. All data is stored locally on your device or securely within your iCloud account. **We do not have access to your data, and no personal information is shared with or stored on our servers.** Your habits, activities, goals, and other personal data are accessible only to you.

5. Sharing Your Information

SnapDay allows users to share their activities with other users or make certain activities public for all SnapDay users. This functionality is entirely optional, and you have full control over what information you choose to share. By default, all your data remains private and accessible only to you unless you actively choose to share it.

In addition, we may share your information in the following limited cases:

- **Legal Requirements:** When required by law or to comply with legal processes.
- **Business Transfers:** In the event of a merger, acquisition, or sale of assets, your data may be transferred to the new owner (only if necessary, and you will be notified).

6. Data Retention

We retain your personal data only for as long as necessary to provide SnapDay's services, comply with legal obligations, resolve disputes, and enforce agreements. Once your data is no longer required, it will be securely deleted.

7. Your Rights

Depending on your location, you may have the following rights:

- **Access and Correction:** Request access to and correction of your personal data.
- **Deletion:** Request deletion of your personal data.
- **Objection and Restriction:** Object to or request the restriction of processing your data.
- **Data Portability:** Request a copy of your data in a portable format.
- **Withdraw Consent:** Withdraw consent for data processing, where applicable.
